Treasurer's Report - Kristin F.

- -\$3,728 in credits. \$4,260 in debits. Net \$-532 for June. Current balance is \$11,060.87

GSR - Sara P.

- 5th ed. BB has been approved with 26 new stories. 30 were removed. There is discussion about where these stories will go, but there are 6 printing items that take precedence. 5th ed. will be out next year.
- There will be an updated, better translated Spanish BB in 2027
- Proposed drafts of new living sober chapters were approved, so that's also in the works.
- AAWS acquired the Everything AA app and it will be Everything AA that's conference approved.
- No action was taken on whether or not to allow Grapevine to accept contributions. Based on this last year, their five year plan is projected to put them positive and they have generated enough new subscriptions to pay off the development of the app. Also, if you purchase/ download the app, do it through the Grapevine/AA and not an App Store.
- There was a floor action at the conference that passed to remove language from the first 164 pages. The word "Eskimo" is being removed from "working with others" on pg 101 and from tradition 8 on pg 171.
- There will be a new pamphlet addressing anonymity on social media out later this year and the military project is complete and available on aa.org.
- Also, contributions to AAWS is down 30% percent and if it dips more, they will have to start cutting services.
- In area news, September is going to be elections, so if you think you'd like to participate on a committee, September is a great time to show up and stand for something.
- Two potential agenda items were discussed for next years conference - one is about removing language from the pamphlet "where money and spirituality mix" and one to create an accessibilities card. I'd like to discuss this more at our next business meeting.
- There was a lot of great stuff in the gsr reports this time - one group started a monthly celebrants game night, one started a lending library to help newcomers, one reported that simply changing the arrangements of their chairs improved attendance, and one report came from a group that began inside crossroads correctional facility and that was really powerful.
- Also, we were asked to participate in raising starter funds for swraasa next year.
- And finally, I updated the binder with a bunch of stuff that's coming up, like MO State Convention and Many Faces of Grapevine, so check it out.

Venmo

- Fees are 1.9% + \$.10 per payment. So for every dollar the fee is \$0.12 cents.
- **Benefit of Venmo is that it accepts Google pay and Apple Pay within the app.
- It does require an EIN number for a business account or can be tied to one person's SSN. For tax purposes, Venmo will issue a 1099 if our payments exceed \$600 in a calendar year. Unless we are nonprofit status. Talked to other groups who use personal accounts of their treasurer or tie the business account to one person's SSN (typically treasurer) and pay the fees and stay under the radar. IRS likely consider this "de minimis" since they are small transactions for the purpose of donating and not for "goods and services". The AA central office advised the same and to just keep adequate records of any emails or mail from Venmo.

Cash App

- Fees are 2.75% of every transaction. The same applies as above for the business account requirements. Cannot use Apple Pay or google pay within cash app.

Zelle

- No fees since we have a Bank of America account and would be tied directly to the banking business account. Just need an email or phone number to set up. This would be the simplest solution, but would possibly limit the amount of contributions.

Google Pay & Apple Pay

- No fees for transactions on Google but .15% charge for any credit card payments via Apple Pay. Same applies for setting up an account as it will need to be tied to an EIN or an individual. May possibly limit the amount of contributions since it is not widely used.

- Lease Committee Update (read by Casey, provided by Amy—sorry it's long y'all, but I felt this deserved the time and research:): As mentioned last month; the lease committee went over the lease draft and the decision was made to do some research around the KC metro to see how other groups were handling the issue of a space agreement/lease.
 - Point 1: After researching (asking other groups in the area if they have leases or not—both at District and Area) it was found that only ONE (The Paseo Group) other group has a lease agreement. They shared that it has been problematic because they have not been able to find a way to sign on behalf of the whole group, so their treasurer has to be the one to sign the document—which has made it challenging for them to get and retain treasurers.
 - Point 2: This prompted me to do some more thorough research on AA's concepts and traditions, which brought me to the ***long form*** of tradition 6 ("An A.A. group ought never endorse, finance or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property and prestige divert us from our primary purpose"). Several hyperlinks are included here if people want to look at these readings more in depth. In an [Editorial written by Bill W. \(A.A. Grapevine, May 1948\)](#), he states: We explain this easily enough; we don't need money. The core of our A.A. procedure is "one alcoholic talking to another," whether that be sitting on a curbstone, in a home, or at a meeting. It's the message, not the place; it's the talk, not the alms. That does our work. Just places to meet and talk, that's about all A.A. needs. Trivial indeed, our expenses! As we neither need nor want money, why risk its hazards? We'd rather stay poor. Thanks just the same!"
 - There is another Grapevine article on Tradition 6 that has a powerful statement: "We (the AA group) decided that, no matter how exciting and how needed such business enterprises were (e.g. a lease in our case), an AA group ought to stay out of them, because discussions of money, property, and prestige kept us wildly distracted from the Twelve Steps."

- These meeting minutes are published on the Unity AA website so please see [“Traditions Checklist”](#) for more guidance on this where it specifically mentions an AA group leasing a small building—These questions * were originally published in Grapevine in conjunction with a series of articles on the Twelve Traditions that ran from November 1969 to September 1971. While they were originally intended as suggestions for individual use, many AA groups have since adopted them and use them as a basis for wider discussion.
- My conclusion after this research is not to continue pursuing the lease option and to keep operating the same way we have been—which is in good faith with Unity Temple. This is just my informed suggestion, but if others feel strongly about this—I am happy to pass the baton on this issue to said folks.
